CSSP– Mock Victims Services Scenario

50 survivors of varying victimizations (DV, SA, stalking) have come to your agency. You are **grant-funded** to provide **victim/survivor advocacy** and **counseling**, although you provide other services that are funded with other sources.

Of the 50 survivors who came to your agency:

30 requested advocacy only - 25 were provided victim/survivor advocacy. 5 did not receive advocacy because of your programs hours of operation

15 requested counseling only - 13 received counseling and 2 did not because the counseling groups were full and they were put on a waiting list. They remained on the list when the reporting period closed

5 requested counseling and job training – All 5 received counseling, but none were provided job training
